

Letter to Support SOD Certificate

I write to respectfully solicit your kind assistance and approval for the ordination of Deaconess Chinwe Omisore to the office of Assistant Pastor.

I would also like to provide some background regarding her School of Disciples (SOD) certificate. Although the certificates for the School of Disciples and her ordination into the office of Deaconess were duly issued in her name, we were unable to collect them from the Church Administrator at the time due to our relocation to Canada shortly thereafter. I made several attempts to follow up with the Church Administrator; however, shortly after our departure from Nigeria, he relocated to the United States to pastor a parish.

Since then, efforts to resolve this matter through the Province have been delayed, largely due to frequent staff transfers within Lagos Province 15. More recently, we were able to reconnect with the new Church Administrator, who has indicated his willingness to assist us (see attached correspondence). The Provincial Pastor is not available to sign the letter, and this may constitute a delay. However, the deadline for the submission of ordination nomination documents is fast approaching.

In light of these circumstances, I humbly request your support, assistance, and approval for the ordination of:

Reissuance of School of Disciples Ordination Certificate

I write to respectfully request the reissuance of my wife's School of Disciples (SOD) training and ordination certificate.

My wife, Deaconess Chinwe Gertrude Omisore, successfully completed the School of Disciples training during the 2006–2007 session and was subsequently ordained as a Deaconess at the Annual Convention in August 2007. At the time, she was serving under Pastor Sola Balogun, then Provincial Pastor, and Pastor Rotimi Anthonio, then Parish Pastor.

Although the certificates for both the School of Disciples and ordination were issued in her name, we were unable to collect them from the Church Administrator due to our relocation to Canada shortly thereafter. I made efforts to follow up with the Church Administrator at the time; however, he has since left that position.

In light of the above, we would be most grateful if you could use your good office to assist us by requesting the reissuance of her School of Disciples certificate.

We understand that the reissuance process may take some time. However, to enable her to meet all the requirements for nomination for ordination by January 29, 2026, we humbly request that a confirmation letter be issued from the Provincial Office stating the date and year of completion of her SOD training and indicating that her certificate is currently being reissued. This letter will serve as interim documentation, pending the issuance of the certificate, which we anticipate submitting to the RCCG Canada Continent Office once processed.
