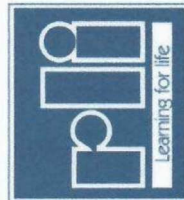

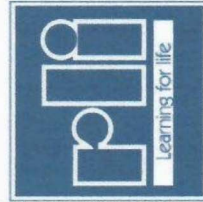


Tenets of The Apostolic Church

1. The Unity of the God head, and the Trinity of the persons therein.
2. The utter depravity of human nature, the necessity for repentance and regeneration, and the eternal doom of the finally impenitent.
3. The virgin birth, Sinless life, Atoning death, Triumphant Resurrection, Ascension, and Abiding intercession of our Lord Jesus Christ, His Second coming, and Millennial reign upon earth.
4. Justification and Sanctification of the believer through the finished work of Christ.
5. The Baptism of the Holy Ghost for believers with signs following.
6. The Nine Gifts of the Holy Ghost for the edification, exhortation and comfort of the church, which is the Body of Christ.
7. Sacrament of Baptism by immersion, and of the Lord's Supper.
8. The divine Inspiration and Authority of the Holy Scriptures.
9. Church Government by Apostles, Prophets, Evangelists, Pastors, Teachers, Elders, Deacons and Deaconesses.
10. The possibility of falling from the Grace.
11. The obligatory nature of Tithes and Offerings.
 - The gift of healing included in this tenet establishes our belief in the Doctrine of Divine Healing.

SPECIAL CHARGES TO ALL ELDERSHIP CANDIDATES

We believe that we have been directed of the Lord to appoint you as an Elder/a Presiding Elder/an Overseer according to the set down principle by the Authority of this Church, in consonance with the word of God. In the presence of God and all these people herein present, we reverently appoint you His servant as we anoint you and separate you by the laying on of hands to the office of an Elder/a Presiding Elder/an Overseer that you guide all those over whom God has made you a head with all humility, holiness and gentleness and as God has Himself directed in His word that you live a blameless life, be the husband of one wife, give yourself to hospitality, and be apt to teach.

Do not give yourself to wine, be not a striker and greedy of filthy lucre and not filthy through the love of money or a brawler or covetous; but be patient, and one who ruleth well his own house, having his children in subjection under the law, and by so doing that you may know how to rule the Church of God. Do not regard yourself as sufficient in your very self: remember at all times that only God is your sufficiency and He who can make you a perfect Elder/Presiding Elder/Overseer. Preach the word of God, and endeavour to do the same in the presence of all men. Protect and honour all men for when you shall appear before God that you may give a good account of yourself how well you have used this office wherein you are being consecrated.
