

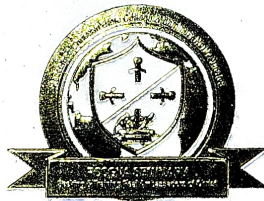

### ORDINATION AS ASST. PASTOR

Calvary greetings to you in the name of our Lord Jesus Christ. This is to inform you that the General Overseer has conditionally approved your nomination for ordination as Asst. Pastor during the Convention coming up from June 6 to 8, 2018. **This approval is however, subject to your parish's compliance with remittance payments through the month of April 2018.** The ordination ceremony is scheduled for 3:00pm on Wednesday, June 6, 2018 at the Convention venue: Pearson Convention Center, 2638 Steeles Avenue East, Brampton ON L6T 4L7

I congratulate you on this promotion and pray that the good Lord will prosper you and the ministry He has committed to your hands. You are encouraged to start seeking the face of the Lord with fasting for the anointing of the Holy Spirit in preparation for this ordination effective from June 1, 2018. **If you do not receive any contrary letter after this, then be assured that by God's grace, you will be ordained during the next Annual Convention.** Additionally, all those to be ordained as Pastors and Assistant Pastors are expected to arrive at the Central Office located at 139 Devon Road Unit 7 Brampton, ON L6T 5L8, on Monday, June 4<sup>th</sup> for prayer lock-in which starts at 11:00 PM till Midnight on Tuesday, June 5<sup>th</sup>. The prayers continue at 8:00AM at the Convention venue on Wednesday, June 6<sup>th</sup> and all ordainees including Deacons/Deaconesses are to join in the prayers preceding the ordination ceremony. It is **mandatory** to attend these prayer sessions as a condition for the ordination. Failure to participate or lateness to the prayer sessions results in postponement of ordination till next year.

Also, please verify that your name is correctly spelled as shown above otherwise, contact **Pastor Lanre Sobo** through email: [lsobo@rccgna.org](mailto:lsobo@rccgna.org) **not later than May 21, 2018** for corrections on your ordination certificate. Requests received for changes after the deadline will not be considered. The applicable fees for the certificates payable by cash or check during the convention are: \$25 for Deacons/Deaconesses, \$50 for Assistant Pastors and \$100 for Pastors. You will be required to present this letter at the ordination ceremony. Any further information and details will be communicated through your Central Office or Parish Pastor. Congratulations!
